The program is first and foremost a child development program that enhances the development of children pregnant women on some form of public assistance and/or classified as homeless.

YWCA Rise: Reaching Impacting Strengthening and Empowering women in the fight against HIV. Educates citizens on appropriate lifestyle choices and sexual responsibility through community outreach, provides free HIV testing, saves lives through prevention counseling to everyone they test. Members received free and confidential HIV testing and counseling.

YWCA EncorePlus offers grassroots breast and cervical health education and awareness to uninsured and underserved women. The program is designed to reduce deaths due to breast and cervical cancers among high-risk, medically underserved women. The program focuses on African American women aged 40 and older because of their disproportionately high death rate from these cancers, chiefly due to the late detection; however, women of all races and ethnicities are served
